Annie and L. A. never show up in a census that I can find. The census after their marriage is 1900.

Troy Allen Strain is Annie's first child. He was born 10 months after Annie's marriage to L. A. I have not found a birth certificate. The only information available is his draft registration and his death certificate.

The 1910 census for Erick Township, Beckham County, Oklahoma was conducted April 18, 1910. Annie and husband Felton B. Walker were here. Felton is a farm laborer. Their children are Alice A. 8, Earnest 6, and Ethyl I. 1 11/12. So Ethyl was born in May, 1908, Alice in 1901 - 1902. Annie is 29 and Felton is 26. They show being married for 7 years. So, whose child is Alice? They were married late 1902 or early 1903. Remember, Annie's son Troy Allen was born May 16, 1898. But he is not with them in 1910.
